ETH VENOM (\$EVN) is a next-generation community-driven crypto project built on Ethereum, designed around transparency, rule-based mechanics, and long-term sustainability.

The project introduces a deterministic deflationary model where token supply reduction is directly linked to Ethereum's price growth, enforced fully on-chain without manual intervention.

Inspired by ancient mythology, serpents, and gladiator trials, ETH VENOM combines strong branding with real utility, predictable tokenomics, and community governance.

PROJECT OVERVIEW

ETH VENOM is a decentralized ecosystem focused on fairness, clarity, and long-term value creation.

Core Pillars

- Transparent presale structure
- Fixed total supply
- Automated, rule-based burn mechanism
- Staking and ecosystem utilities
- Community-driven governance

VISION:

To build a long-lasting crypto brand where scarcity is enforced by rules, not promises.

MISSION:

To restore trust in crypto launches by removing hidden mechanics, discretionary burns, and unfair distribution models.

THE CHALLENGE

The modern crypto market faces persistent issues:

- Arbitrary burn promises without enforcement
- Manual supply control by project teams
- Overhyped meme tokens with no sustainability
- Presales favoring insiders and whales

Investors increasingly demand:

- Long-term alignment with major ecosystems


THE ETHVENOM SOLUTION

ETH VENOM addresses these issues through:

- A fixed-supply ERC-20 token
- A finite burn reserve
- An automated burn mechanism tied to ETH price growth
- A progressive, fair presale with no private rounds

Supply reduction is deterministic, transparent, and irreversible.

LORE & IDENTITY



In ancient times, venom was not poison — it was power.

ETH VENOM represents patience, structure, and survival through rules rather than chaos.

UTILITIES & ECOSYSTEM

1 Staking

\$EVN holders may stake tokens to earn rewards from the staking allocation.

Reward structures favor long-term commitment.

2 Venom Vault

Early supporters gain access to exclusive ecosystem utilities and future benefits.

3 Payment Utility

\$EVN is designed to function as a payment asset within ecosystem services and partner platforms.

Supported and planned payment options:

- * ETH
- * USDT
- * Credit / Debit Card (via on-ramp integration)

4 Marketplace (Phase Expansion)

Planned ecosystem utilities may include:

- * NFTs
- * Digital assets
- * Collectibles and access-based utilities

5 Airdrops

Airdrops are distributed based on participation and holding behavior.

6 Governance

\$EVN holders participate in governance decisions, including:

- * DEX / CEX listing priorities
- * Ecosystem expansions
- * Utility rollouts

TOKENOMICS

Total Supply: 1,300,000,000 EVN (Fixed)

Allocation	Percentage
Presale	35%
Staking Rewards	20%
Burn Reserve	20%
Community Airdrops	10%
Team & Development	8%
Liquidity Pool	7%

Tokenomics Principles:

- * **No minting after deployment**
- * **No hidden allocations**
- * **Team tokens subject to vesting**
- * **Burn reserve used exclusively for automated burns**

ETH HYPER BURN MECHANISM

ETH VENOM introduces a rule-based deflationary burn system directly linked to Ethereum's price performance.

Burn Rule

For every \$500 increase in ETH price

10,000,000 EVN are automatically and permanently burned

Tokens are burned exclusively from the Burn Reserve

Burns are cumulative and irreversible

Example

ETH Price Increase	EVN Burned
-----	-----
+\$500	10,000,000
+\$1,000	20,000,000
+\$2,500	50,000,000

ETH HYPER BURN MECHANISM

Technical Enforcement

- * ETH price sourced from a decentralized oracle (e.g. Chainlink ETH/USD)
- * Burns are:
 - * On-chain
 - * Public
 - * Verifiable
 - * No manual triggers
 - * No owner override
 - * Once the Burn Reserve is depleted, the burn mechanism halts automatically

Purpose

- * Align EVN scarcity with Ethereum growth
- * Remove discretionary supply control
- * Reward long-term holders
- * Create predictable deflation

PRESALE STRUCTURE

ETH VENOM uses a 20-week progressive presale model.

Presale Rules

- * 20 stages
- * 1 stage = 1 week
- * Approximately 15% price increase per stage
- * No private or seed rounds
- * Anti-whale limits enforced

Accepted Payments

- * ETH
- * USDT

All presale logic is enforced via smart contracts.

CLAIM, LIQUIDITY & SUPPLY CONTROL

Claim:

- * Claim opens at Token Generation Event (TGE)
- * Tokens claimed directly to user wallets

Liquidity:

- * Initial liquidity added post-TGE
- * LP tokens locked for a minimum of 12 months

Unsold Tokens:

- * Any unsold presale tokens are permanently burned at TGE
